below. They type of information collected depends on the purpose for which it is collected and used. SAMWUMED will only collect information that we need for that purpose.

- 3.1.2. SAMWUMED directly collects information when provided with personal details, by way of example, when a product or service is purchased from us or when enquiries are submitted to us or when we are contacted. Where possible, SAMWUMED will inform data subjects which information is required by us and which information is optional.

on computer or files. When a server uses a web browser to read cookies, they can help a website deliver a more user-friendly service. In order to protect privacy, browsers only give websites access to the cookies that that have already been sent.

3.3.2. Why use cookies?

Cookies are used to learn more about the way our content is interacted with and helps SAMWUMED to improve the user experience when visiting our website. Cookies remember the type of browsers used and which additional browser software has been installed. - 4.1.17. Collect information about the device used to view the site, such as IP addresses or the type of internet browser or operating system used, and link this to Personal Information so as to ensure that the site presents the best suitably tailored web experience.
